



## Thresholds – The Public Contracts Regulations 2015

When procuring goods or services over the set financial thresholds a Contracting Authority must consider their obligations under the Public Contracts Regulations (PCR) 2015.

Health / NHS organisations are also required to comply with the Procurement, Patient Choice and Competition (No 2) Regulations 2013 when advertising for services.

The European Commission announced revised threshold limits for public procurements on 31 October 2019. The revised limits apply to all contract opportunities arising from 01 January 2020.

Contracting authorities should note that the financial thresholds have, effectively, been increased as a result of the revised limits.

A services contract will fall within the scope of the Light Touch regime if it is for the certain types of health, social and other services listed at Schedule 3 of the PCR 2015. If a service is not listed at Schedule 3 of the PCR 2015 it will be subject to the full regime rather than the Light Touch regime.
